The Good Lives Model of Rehabilitation

During this two-day workshop, participants will be introduced to the underlying theory and practice guidelines of the Good Lives Model of offender rehabilitation (GLM). The limitations of formulating cases primarily in terms of dynamic risk factors will be discussed along with the advantages of adopting a strengths-oriented approach.

The fundamentals of GLM assessment and case formulation will be presented and participants guided through the process of conducting both by working through a number of clinical examples. In the second day, the primary focus is on using the GLM to construct good lives intervention plans, drawing from cases vignettes and cases that participants have brought along from their own practice.

TONY WARD PhD, DipClinPsyc

TonyWard, PhD, Dip Clin Psyc, FRSNZ, is currently professor inclinical psychology at Victoria University of Wellington, New Zealand. He has taught clinical and forensic psychology at several universities and was a past director of the Kia Marama Treatment Unit for men who have sexually abused children. Professor Ward has authored more than 430 academic publications and is on the editorial boards of several leading forensic psychology journals. His current research projects include: (a) explanation and inquiry in clinical research and practice; (b) normative issues in forensic psychology; and (c) change processes in the psychopathology and forensic/correctional domains. He has run workshops and given talks on the GLM all over the world including Ireland, Belgium, England, Japan, Canada, Germany, Hong Kong, Australia, Wales, Singapore, Scotland, and the USA.

MARY BARNAO PhD, MA Psych (Clinical)

Dr Mary Barnao is a registered Clinical Psychologist who previously worked for the regional forensic service in Wellington. In this role she provided assessment and treatment for people with major mental disorder and offending histories, supervised clinical psychologists and other mental health practitioners, and was involved in a range of innovative service development initiatives. These initiatives included implementing the GLM with forensic mental health service users in an inpatient setting.



Dr Barnao is employed as a Clinical Practice Advisor in the Clinical Psychology Programme at Victoria University of Wellington. She also has a private practice, where she sees adults with a wide range of psychological issues

Dr Barnao's PhD explored the application of the GLM to forensic mental health. She has authored several journal articles and book chapters on the GLM and its application to forensic service users. Her other publications relate to rehabilitation frameworks in forensic mental health, ethical decision-making in forensic practice, and forensic service users' perceptions of rehabilitation. She has run workshops and given talks on the GLM in Belgium, Singapore, Taiwan, and New Zealand.
